SUBJECT:

Consideration of a Resolution Appointing Muhammad Latif as a Member of the City of Madera Transit Advisory Board

RECOMMENDATION:

Staff recommends adoption of a Resolution appointing Muhammad Latif as a member of the Madera Transit Advisory Board (TAB)

SUMMARY:

There is a vacancy in District 2. In order to continue to have TAB meetings, a quorum of 4 members need to be present. Councilmembers are asked to make nominations for new appointments to fill vacancies within their districts. The current nomination for the Board is as follows:

DISCUSSION:

The TAB is comprised of 7 members of whom 6 are nominated by individual Council members and 1 is appointed by the Mayor. Board members serve a term of 2 years or until the Mayor or Council Member who nominated the TAB member is no longer serving, whichever period is shorter. The members typically have transit knowledge and experience which is beneficial when participating and making recommendations during TAB meetings aimed at improving the City's transit services.

Mr. Latif submitted an application to serve as a TAB member on August 1, 2019. He is currently serving on the City's Americans with Disabilities Act Advisory Council and on the Loan Review

Committee. He has resided in the City of Madera for 19 years and is looking forward to serving on the TAB to the best of his abilities to try to make a positive contribution to transit services for the City.

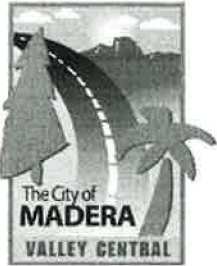
WHEREAS, Councilmember Jose Rodriguez has nominated Mr. Muhammad Latif for appointment to the City of Madera Transit Advisory Board.
