Councilmember Derek Robinson stated that he enjoyed the ribbon cutting of the Love Truck Center.

Councilmember Cece Gallegos had nothing to report.

Mayor Pro Tem Garcia stated he is very uncomfortable doing things this way and is looking forward to getting back to normal. He stated he likes for the citizens and residents to be able to attend the meetings and be vocal about how the Council is guiding the City. Mayor Pro Tem Garcia requested a

report that updates them on the Veterans' facility and the low-income facility that the City is going to build. He also requests a report from the Fire Chief which updates them on the number and type of fires combatted in the last year.

Councilmember Steve Montes had nothing to report.

Councilmember Donald Holley stated he loves what they are doing for the City. They shouldn't panic and do the right things for the constituents. He didn't know if the City Manager was keeping Madera Unified School District (MUSD) updated.

Mayor Medellin asked City Manager Arnoldo Rodriguez if he'd like to reply.

City Manager Arnoldo Rodriguez stated he is in constant communication with MUSD and State Center Community College. Collectively, they felt it was the correct thing to do and have the Madera Metro Route 3 go offline Friday due to the numbers currently using the route. Dial-A-Ride services are still available.

Mayor Medellin thanked Information Systems Manager Mark Souders, Communications Specialist Joseph Carrello and City Manager Arnoldo Rodriguez and his team for putting together this meeting format in such a short timeframe. He like doing meetings face-to-face also but guesses they will be doing things this way probably through May.

Mayor Medellin thanked Arnoldo Rodriguez for being in constant communication with MUSD, Madera Community Hospital, Camarena Health Center, Board of Supervisors, and Madera County Health Department. They all agree that the message they send to residents should be a unified message with less confusion the better.

Mayor Medellin stated that from the Offices of Congressman Jim Costa and the Senator Caballero, he heard that Madera is very pragmatic and is working together with others.

Mayor Medellin insists on knowing where they are in discussing Development Impact Fees. The Council gave staff this topic as a priority.

City Manager Arnoldo Rodriguez stated they haven't made the progress that they want although it is not from lack of effort. He understands it is a priority for Council. COVID-19 pandemic has them focusing their efforts elsewhere right now.

Councilmember Garcia stated they need to move forward and advised City Manager that they need to update their fees even if not all like it. It has been too many years that they have not moved on

Councilmember Garcia asked to revisit student transportation to the college.

City Manager Arnoldo Rodriguez stated the college is closing tomorrow which why the route is going offline.

Mayor Medellin thanked staff for putting this meeting together. He thanked the public for participating.
