### **RECOMMENDATION:**

Approve a Minute Order in Favor of the Sustainable Groundwater Management (SGM) Grant Program Proposition 1 Implementation Round 1 Application on behalf of the County of Madera

### **SUMMARY:**

The City received a request for a letter of support from the County to support the Sustainable Groundwater Management (SGM) Grant Program Proposition 1 Implementation Round 1 application. The application provides funding in support of the Madera County Groundwater Sustainability Agency (GSA) and Triangle T Water District GSA Chowchilla Bypass Recharge and Flood Reduction Project Phase 1.

### **DISCUSSION:**

The grant application will assist in support of funding of the Madera County GSA and Triangle T Water District GSA Chowchilla Bypass Recharge and Flood Reduction Project Phase 1. This project is intended to provide drought resiliency and is fundamental to reducing subsidence and the regional sustainability of groundwater. In addition, Madera County and Triangle T Water District will benefit through enhanced water quality to regional domestic well owners.

### **FINANCIAL IMPACT:**

Approval of this Minute Order will not have an impact on the City's General Fund.

### **CONSISTENCY WITH THE VISION MADERA 2025 PLAN:**

### **ALTERNATIVES:**


As an alternative, the Council may elect to not provide a letter of support. Such a decision may not result in County's ability to secure grant, but neither will it assist in that outcome.

The City of Madera supports the Sustainable Groundwater Management (SGM)'s Grant Program Proposition 1 Implementation Round 1 application in the Madera and Chowchilla Subbasins.
