Budget Amendment related to the November 3, 2020 Consolidated Presidential General Election

RECOMMENDATION:

Adopt a Minute Order Approving a Budget Amendment related to the November 3, 2020, Consolidated Presidential General Election in the amount of \$101,322.15

SUMMARY:

The City received an invoice in the amount of \$127,670.15 from the Madera County Elections Office for the Election Management of the November 3, 2020, Consolidated Presidential General Election. The Madera County Elections Office rendered services on November 3, 2020 for the Election of Council Members for Districts 2, 4, 6, Mayor, and Measure R.

DISCUSSION:

Staff is requesting allocation of funds for the Intergovernmental Charges account. Staff is proposing that the General Fund cover the costs of the election. It is noted that the City's fair share exceeded projected costs which may partially be attributed to safety measures due to the COVID-19 pandemic and Measure R. Council may recall that at the time that Measure R was being contemplated, initial estimates to place it on the ballot ranged between \$90k to \$100k, depending on the number of registered voters, to place on the ballot. Since then, staff has been notified that the costs for Measure R, three Council districts, and Mayoral election totaled \$127,670.15. Staff initially budgeted \$26,348 for the election, therefore a budget amendment of \$101,322.15 is being requested.
