SUBJECT:

Determination under Elections Code Section 10229 whether to Appoint Nominated Candidates in Council Districts 1, 3, and 5

RECOMMENDATION:

- 1. Adopt a Resolution to Appoint Candidates, or
- 2. Adopt a Resolution to Hold the Election, or
- 3. Take no action

SUMMARY:

Per California Elections Code Section 10229, when there is only one or no nominees for elective office, the governing board may appoint such nominee to off or hold the election as scheduled. Here, the City has one nominee for the Council seats in Districts 1, 3, and 5. Therefore, the Council may appoint the nominees or proceed with holding the election.

DISCUSSION:

The City is holding a Consolidated General Election on November 8, 2022, for the purpose of electing councilmembers to Districts 1, 3, and 5. The period for nominating candidates closed on Friday, August 12, 2022 with only one candidate each being nominated to Council Districts 1, 3, and 5. See Attachment 1, letter of August 16, 2022, from the Madera Registrar of Voters.

The candidates are incumbents:

- Cecelia "Cece" Gallegos (District 1)
- Steve Montes (District 3), and
- Elsa Mejia (District 5)

Under these circumstances and in accordance with Elections Code 10229, the City Council may take one of the following courses of action:

- 1. Appoint to the office the person(s) who has/have been nominated.
- 2. Appoint to the office any eligible elector (voter) if no one has been nominated.
- 3. Hold the election if either no one or only one person has been nominated.

In the event the person nominated is appointed to office, the person appointed shall qualify and take office and serve exactly as if elected. In addition, the City Clerk shall not accept for filing any statement of write-in candidacy after the appointment is made.

The City Clerk has complied with Elections Code Section 10229 by providing the City Council with her Certification (Attachment 2) and by publishing the required notice in a newspaper of general circulation.

The Council has the option to adopt a Resolution making the appointments (Option 1) or to adopt a Resolution to hold the election (Option 2).

FINANCIAL IMPACT:

The cost for election services for the three Council seats is estimated to be \$120,000. The amount is included in the proposed budget for Fiscal Year 2022/23; however, should the election not be held the cost of the election would potentially be a savings to the City.

CONSISTENCY WITH THE VISION MADERA 2025 PLAN:

Strategy 302 – District Representation: Establish district representation in Madera with a separate election process for Mayor.

In accordance with Elections Code Section 10229 (a) If, by the 88th day before the election, or the 83rd day before the election, if an incumbent fails, (i) no one or only one person has been nominated for any office that is elected on a citywide basis, or (ii) no one or only one person is nominated to be elected from or by a legislative district, or (iii) in the case of any office or offices to be elected at large, the number of persons who have been nominated for those offices does not exceed the number to be filled at that election; the city elections official shall submit a certificate of these facts to the governing body of the city and inform the governing body of the city that it may, at a regular or special meeting held before the municipal election, adopt one of the following courses of action:

- (1) Appoint to the office the person who has been nominated.
- (2) Appoint to the office an eligible elector if no one has been nominated.
- (3) Hold the election, if either no one or only one person has been nominated.

The city elections official shall publish a notice of the facts described in this section and the courses of action available under this subdivision. Publication shall be made pursuant to Section 6061 of the Government Code in any newspaper of general circulation as designated by the city elections official.

Please provide proof of publication of the above referenced notice to my office upon receipt. Once I have received proof of publication and notice of the City Council's decision, my office will move forward accordingly.

I, Alicia Gonzales, City Clerk of the City of Madera, do hereby certify pursuant to Section 10229 of the Elections Code of the State of California, the following facts relating to the General Municipal Election to be held on Tuesday, November 8, 2022.

As of the close of the nomination period on Friday, August 12, 2022 for Members of the City Council representing Districts 1, 3, and 5, there are not more candidates than offices to be elected.

Section 10229 of the Elections Code allows one of the following courses of action to be taken by the City Council:

- (1) Appoint to the office the person(s) who has/have been nominated.
- (2) Appoint to the office any eligible elector (voter) if no one has been nominated.
- (3) Hold the election if either no one or only one person has been nominated.

A notice of these facts was posted on Thursday, August 18, 2022, and will be published on Thursday, August 18, 2022 in a newspaper of general circulation in the City pursuant to § 6061 of the Government Code. After the fifth day following the date of publication, the City Council will meet to either make the appointment(s) or direct an election to be held. The person(s) appointed, if any, shall qualify and take office and serve exactly as if elected at a municipal election for the office.

The City Council will meet at a Special Meeting on Wednesday, August 24, 2022, to either make the appointment(s) or direct an election to be held.

If, by the 75th day before the municipal election, no person has been appointed to the office(s) pursuant to (1) or (2) above, the election shall be held.

If the City Council makes an appointment pursuant to §10229, Elections Code, the City Clerk shall not accept for filing any statement of write-in candidacy which is submitted after the appointment is made.
