1. CUP 2023-09, SPR 2023-27 & TPM 2024-01 - Building for Christ Ministry (Report by Robert Smith)

Recommendation: Conduct the hearing and;

a. Adopt a Resolution of the Planning Commission of the City of Madera determining the project is Categorically Exempt pursuant to Sections 15301 (Existing Facilities), 15315 (Minor Land Divisions) and 15332 (Infill Development) of the California Environmental Quality Act (CEQA) Guidelines, and approving Conditional Use Permit 2023-09, Site Plan Review 2023-27 and Tentative Parcel Map 2024-01 subject to the findings and conditions of approval.

Adopt a Resolution of the Planning Commission of the City of Madera adopting a Finding of Categorical Exemption from CEQA pursuant to CEQA Guidelines Section 15303 (new Construction or Conversion of Small Structures) and Section 15332 (In-Fill Development) for the project and approving Precise Plan 2023-02 and Site Plan Review 2023-08 based on and subject to the findings and conditions of approval.
