Adopt a Resolution of the Planning Commission of the City of Madera recommending the Council of the City of Madera adopt Determinations of Categorical Exemptions pursuant to California Environmental Quality Act (CEQA) Guidelines Sections 15301/Class 1 (Existing Facilities) and approving Conditional Use Permit 2024-11 and Site Plan Review 2024-16, subject to the findings and conditions of approval.
