Mayor Garcia called for a recess at 6:40 p.m. Meeting resumed at 6:45 p.m.

#### **PUBLIC COMMENT:**

The first 15 minutes of the meeting are reserved for members of the public to address the Council on items which are within the subject matter jurisdiction of the Council. Speakers shall be limited to three minutes. Speakers will be asked, but are not required, to identify themselves and state the subject of their comments. If the subject is an item on the Agenda, the Mayor has the option of asking the speaker to hold the comment until that item is called. Comments on items listed as a Public Hearing on the Agenda should be held until the hearing is opened. The Council is prohibited by law from taking any action on matters discussed that are not on the agenda, and no adverse conclusions should be drawn if the Council does not respond to public comment at this time.

City Clerk Alicia Gonzales announced that Councilmember Mejia left the meeting at 6:25 p.m. and since there is no Councilmember on Zoom, it is no longer required to take roll call votes.

Vincent Paul Enriquez owner of Pablo Taxi spoke about Gold Taxi violations and his concerns which he stated have not fully been addressed through Code Enforcement and the Police Department. Mr. Enriquez stated he wants these issues resolved before end of year and that he is in the process of suing the Police Department and Claudia Mendoza (Neighborhood Preservation Supervisor). He handed some pictures to the City Clerk.

Lynette Cortes Howden, a resident of Madera expressed disappointment with members of the Council including Mayor Garcia and Councilmember Rodriguez for giving public comment at the SECD Board of Trustees meeting yesterday without being properly informed. She asked that Council, including the Mayor refrain from making public endorsements or statement without proper discussion or directives from their constituents. She is certain Council has enough issues to address that are within the scope of their jurisdiction. Mayor Garcia asked that Ms. Howden provide her contact information to City Clerk Alicia Gonzales.
