On an annual basis, the City of Madera receives Community Development Block Grant (CDBG) program funds from the U.S. Department of Housing and Urban Development (HUD). The purpose of CDBG funds is to develop viable communities through providing decent affordable housing, a suitable living environment, and expanded economic development opportunities for persons of low and moderate-income.

All citizens/organizations interested in applying for CDBG funds are encouraged to attend the Application/Technical Assistance workshop. Below is an approximate timeline for the awarding of the annual CDBG funds.
