

MEETING MINUTES

Tuesday, April 16, 2024 5:30pm Council Chambers City Hall

CALL TO ORDER:

Cynthia Ortegon called meeting to order at 5:30pm.

PUBLIC COMMENTS:

Natalia Austin from Madera County Transportation Commission states that they are holding a public hearing on April 24th at 3pm. The purpose of the public hearing is to ask the community for feedback on the transit systems in Madera and of their needs from transit systems. The feedback will be reviewed on April 30th. They are accepting comments online, through mail in, and through phone.

DISCUSSION ITEMS:

A. Consent Agenda

Motion to adopt the Consent Agenda as presented. Motion/Second by members Albonico and Luna. Motion carried.

B. Bi-Annual Secret Rider Evaluation Reminder

Cynthia explained to the board how the evaluation would work, and Xochitl handed out physical copies of the evaluation to the board members.

C. Madera Metro Map Phone Number Request

Cynthia explained the request to include the dispatch number on the Madera Metro Maps.

Xochitl explained that the main map was full of other information already and it might get lost if it was added onto that map. An alternative Xochitl gave was to put the phone number on the schedule The board agreed it sounded reasonable.

D. TAB Meeting Schedule

The board agreed that the scheduled meetings stated below work for everyone.

E. Updates

Intermodal Renovation

Greyhound has not been physically located at the intermodal since COVID hit. They did not renew their lease once it expired. The bus still stops at the Intermodal. Madera County Connection also stops here. Madera Taxi Cab continues leasing a small office in the building.

Staff shared that the renovation is currently in the design phase and getting construction documents together for the north wing. Staff reminded members that the renovation was approved by city council last year.

Marcela explained how grant staff will be moving into the building once completed so transit staff is present as this is one of our centrally located transfer points. RRM Design Group was contracted to complete this project. Some deliverables include: a meeting space, waiting area, lobby and shelter space outside for bus riders waiting.

• Transition Plan

Marcela shared updates with the plan which was put in place to streamline the routes and target areas that were not being served by the previous transit system. It was rolled out on January 6, 2024, and there is still information being collected to make improvements.

Maria asked if there is more use of the transit system and new routes. Xochitl explained how numbers are still being gathered but at face value there is more ridership across all routes; even though the numbers are the same, they are now spread across four routes instead of the previous three.

Marcela also explained how the bus shelter relocation project is on Phase 1 this fiscal year and the next phase will not start until next fiscal year. As of now, the stops are still being monitored to see where shelters need to be relocated to. An example is seeing which new stops can accommodate a shelter and see if they need any additional infrastructure such as concrete, etc.

Transit Workshop

Marcelas shared that at during the January 17th council meeting, she gave a presentation to city council going over options for micro transit. She explained that in short, micro transit moves away from a traditional public bus system and moves towards the option of an electric vehicle system that operates more like the dial a ride. The first phase is to navigate through the local needs of the community of Madera.

Cynthia mentioned that she would like the board to do some more research such as visit other cities or local counties to see their public transportation systems or if they have micro transit systems in place as well.

Marcela stated that since we are unable to renew our contract with MV, due to its renewals being maxed out, in the early part of next year, we will begin the procurement process to secure a contract with a new transit operator. We need to know what, if any, changes are needed or wanted from the community prior to putting out an RFP for a new transit operator.

Cynthia asked Natalia if the county is also considering implementing a micro transit system. Natalia stated that Madera County is in the process of completing a study in which they are weighing their options to determine which system best fit the needs of Madera County.

Cynthia leaves at 6:16pm.

BOARD MEMBER REPORTS

Andrew stated that one of the CNG pumps is running as of now. The company that manufactures them has been bought out by a different company, so they are behind on manufacturing the necessary parts. There is also construction going on at the child nutrition center, so the parking lot is busy with the buses and construction going on. In conclusion, there is no estimated date for when all the pumps will be fixed.
